

Continuing on a happy note, I submit the following profile which I mentioned in the February Newsletter. I consider myself fortunate to be associated with this "real lady".

PROFILE OF A MOTORCYCLE RIDER

"I date way back - To a Harley D. 1947 74 which I dubbed "Tessie". Just a kid who had been introduced to motorcycles by an older sister who dated a biker and I got drug along because I had nowhere else to go. It changed my outlook on life. In 1949 I bought Tessie - couldn't ride a stitch. I rode the bus to get her, pushed her blocks so nobody who knew that seller could see that buyer. Then I cranked it off (kick start) put it in gear and headed home. No license, no past experience, no nothing. I made it home, 5 miles or so through the main drag of Ogden, Utah. I had that bike two years. Had a blast. No girls rode bikes then - But I did. Then came a lull in life - marriage, kids - the works. No bikes. I used to turn cartwheels when a group of bikes passed by. Then after years of raising kids, they all grew up. I was single again and looking for a good H.D. to buy, when along came the "Kitten", my 1973 R75/5. She came to me bare naked, and I dressed her to suit my taste. At first it was just the bare bike - lots of trips around the block to gain confidence after all those years. This was 1975. My first long trip was to Hyden, Kentucky. Not a trip; a training session. I hit sleet, rain, wind, sun, and whatever else comes from above. I had cloth gloves and a windbreaker with a sweater - I learned but good. That year I went to Calgary Canada and what a trip that was.

I went to Calgary with my brother-in-law from Denver, Colorado and a group of his co-workers from Frontier Air Lines. We had a good time after the guys got used to the idea that a female was going. We were like the Keystone Cops - what laughs - what pleasure. That's a story unto itself. Since then, I've been all over - to Los Angeles and up the coast to Oregon, Washington and back home; Down Skyline Drive and Blue Ridge Parkway; to Boston, up the coast to Maine and to the Vermont Rally; to the Wisconsin Dels twice; to Minnesota, Georgia, south through Kentucky and up to Maryland; and in every nook and cranny in Ohio, Kentucky and Indiana.

Since February of 1975, I have put 112,000 plus miles on Kitten, 7,000 plus miles on my beautiful white bike that died in 79, and over 12,000 miles on Smoky Joe, my 1979 R100 RT. I've enjoyed every inch of my rides.

Besides all these side trips, I ride to work every day, 3/4ths of the year, maybe more. My bikes hardly ever get put up for winter. We just wait the snow storms out.

It's a good life, biking. You meet the nicest of people, both into bikes and out. Your horizons surely broaden. It's nothing for me to go to Alliance, Ohio from Dayton for brunch, or down south to Bob Evans' Farm. Along with traveling, I've become an avid camper. I'd just as soon sleep in my tent as my house.

My bike, my tent and I are good friends. Look for us. We turn up almost anywhere."

TAX TIPS FROM DAN BRAUN Hereafter to be known as H & R Braun (per Don Smith)

"1. Laid off or know someone that is? The costs of finding new employment in the same field are tax deductable (even if you do not itemize) (Sch.A). You or the person laid of must keep a diary of mileage, food, lodging, phone etc., relating to your employment search. Note: Employment must be the same type work - waitress to waitress, secretary to secretary, sales to sales. 2. Summer camp is a child care expense that qualifies for tax credit (Code section 44A). The tax court approves a credit for the cost of sending a youngster to a sleep-away camp (201 Tan. 79 TC No.31). Note: Spouse must be gainfully employed; single parent must be employed. 3. Good news for married filing joint. When both work, 5% reduction in the lesser spouses income for 82-83 season and in 83-84 season, it goes to 10%. Example: John and Mary Doe both work. John earns \$26,000; Mary earns \$30,000. (Didn't want to sound sexist) John's income is reduced by 5% or \$1,300.00; (\$2,600.00 in 83-84) thereby reducing the joint taxable income from \$56,000. to \$54,700; (\$56,000. to \$53,400. in 83-84). With two of the tax laws (to make it easy for me), if a husband is working and earning \$1500. per month and the wife gets summer or part time employment and earns \$600. per month, (let us say \$1800. for June, July and August), by sending the children to the YMCA Camp/ or etc. at a cost of \$160.00 per week for 2 weeks each, total cost \$640., and the cost of child care for the other 10 weeks is \$50.00 per week or \$500.. total child care expense \$1,140.
