Motorcycle chase in BG ends with Arrest.

A motorcyclist eluded BG police during a high speed chase Tuesday night, but was subsequently arrested at his home and his motorcycle confiscated.

Grant Guthrie, was charged with failure to comply with the order of a police officer, listed as a fourth degree felony as there was a "substantial risk" or physical harm in the events of the pursuit.

Just after 11:30pm, BG Ptl. Dan Adams observed five cyclist northbound on Main Street, and witnessed two of them doing wheel stands. The rider was cited, at that time, for failure to maintain reasonable control. The second cyclist fled with Ptl. Adams in pursuit, but the chase was called off when police said speeds reached in excess of 100mph

A yellow pullover shirt was to later be his waterloo. Shortly before midnight Lt. Tom Brokamp spotted the four remaining cyclist at Prospect and E. Wooster.

As Lt. Brokamp was exiting from the offices, Guthrie, identified by his yellow jersey, did a wheelie and passed within three feet of Brokamp's cruiser heading north on Prospect. Speeds reached 80mph during the chase, according to the report.

The cyclist reportedly spun out at the Poe Rd. intersection, then accelerated across N. Main R100(mod. RS). Street - against the red light traveling an estimated 60mph. At that time the pursuit was called off while Gutherie continued west, allegedly in excess of 100mph.

The Lucas County Sheriff's office was notified and told that Wood County would take custody when Guthrie was apprehended. Sheriff's Deputies later responded that they had found two motorcycles at Guthries home and had arrested him. The incriminating yellow shirt was also found in his possesion..

The offending motorcycle was conficated while Guthrie was booked into the Wood County Justice Center.

(Ed's. note) This story demonstrates that there is really no place for these kinds of high speed shenaniganson on crowded village streets. The BG police are to be commended for acting with intelligence and restraint, by calling off the pursuit when spreeds became dangerous to the public welfare and that of the pursuing officers.
